CLASSIC VEHICLE LICENSE PLATE APPLICATION
NRS 482.3816

A Nevada resident who owns a passenger car or light commercial vehicle (having a manufacturer's rated carrying capacity of 1 ton or less), manufactured at least 25 years prior to the date of application, may apply for Classic Vehicle license plates. A Classic Vehicle must contain only the original parts that were used to manufacture the vehicle or replacement parts that duplicate those original parts. First time application for this plate type must be done in person at a full service DMV office. You must present your Nevada evidence of insurance when you visit the DMV. Personalization of these plates is not allowed.

The first-time fee for an Old Timer license plate is \$37.00, which includes a Technology fee and Prison Industry fee, for those motor vehicles exempted from emission testing, 1968 and newer, the Department will collect a one-time fee of \$6.00, to be deposited into the pollution control account. These fees are in addition to all other registration fees. The renewal fee for an Old Timer license plate is \$11, in addition to all other applicable registration fees.

If your vehicle is currently registered, you have the option to maintain your current vehicle expiration date, or renewing for a full twelve (12) month period. Credit for the unused portion of your current registration will be applied. You must surrender your current license plates to the Department in order to transfer this credit.

An owner of a Classic Vehicle must certify annually that the vehicle has not been driven more than 5,000 miles since the preceding annual registration in order to be exempt from compliance with emission standards. (NAC 445B.574) A passing emissions test is required for renewal if the vehicle is driven more than 5,000 miles. Attach Department form EC-18, Odometer Certification for Emission Exemption to this application.
