

Nevada Driver's License Withdrawal Codes

A withdrawal is any adverse action taken against a motorist's driving privilege. Withdrawals are listed on Nevada ten-year and school bus driver history reports but not on three-year reports. "Status" reflects the specific type of withdrawal action and is one factor in determining reinstatement requirements.

Explanations and Abbreviations

NO LONGER USED - Obsolete codes that may appear in older entries on driver history reports.

AFTER HEARING - The motorist appealed the withdrawal action at a DMV Administrative Hearing but the judge affirmed (upheld) the action. DMV hearings are completely separate from hearings in criminal court.
