

VETERAN SPECIAL LICENSE PLATE APPLICATION
NRS 482.3765 through 482.3783, and 482.384

A Nevada resident who is a veteran of the Armed Forces of the United States, who, as a result of their service:

- Was captured and held prisoner by a military force of a foreign nation; or
- Was awarded the Purple Heart; or
- Is a Pearl Harbor Veteran or Survivor; or
- Has been awarded the Congressional Medal of Honor; or
- Has been awarded the Bronze or Silver Star.

Is entitled to two sets of specially designed license plates for passenger cars, motorcycles, trailers or light commercial vehicles having a manufacturer rated carrying capacity of 1 ton or less, for his/her own personal use.

A qualifying Veteran of the Armed Forces of the United States, who, as a result of his/her service, has suffered a qualifying, service-connected disability and receives compensation from the United States for the disability; may apply for the addition of the International Symbol of Access to certain special license plates ([NRS 482.0962](#) and [NRS 482.384](#)).

A certificate or letter from the Department of Veterans Affairs or the Department of Defense must be presented with the application. Certificate or letter must indicate a 100% disability rating, a combined service-connected disability rating of 100%, or a service-connected disability and certificate/letter stating that the applicant is considered totally and permanently disabled due to their service-connected disability, in order to receive special plates with the International Symbol of Access.

An owner or operator of a motor vehicle displaying special disabled plates issued pursuant to [NRS 482.377](#) may park in a parking space designated for the handicapped ([NRS 484B.463](#), [484B.467](#)).

PLEASE NOTE: These parking privileges are unique to Nevada and may not be applicable or honored in other states.

The following documentation must be attached to this application to determine qualification.

- **Ex-Prisoner of War**
 - Form DD-214 Discharge Certificate with Ex-POW status; or
 - Separation papers with Ex-POW status noted; or
 - Written notification from the Military Personnel Records Center, showing Ex-POW status.
- **Purple Heart Recipient**
 - Form DD-214 or DD-215 Discharge Certificate with Purple Heart recipient status noted on the form; or
 - General Order awarding the Purple Heart from a service headquarters signed or stamped "Official Copy"; or
 - Form WG05455 for World War II recipients; or
 - Other acceptable official documentation as determined by the Department.
- **Pearl Harbor Veteran/Survivor**
 - Proof of your duty station; and
 - A copy of the Pearl Harbor Survivors Association card with association number and member's name; or
 - DD-214 listing the duty station on December 7, 1941 as within a three-mile radius of the exact location of the bombing.
- **Congressional Medal of Honor Recipient**
 - DD-214 Discharge Certificate with Congressional Medal of Honor recipient status noted on the form; or
 - Approved documentation supporting the current membership status or letter from the Department of Veteran's Affairs; or
 - An official Medal Citation Order
- **Bronze or Silver Star**
 - General Order awarding the Bronze Star with "V" Device, Combat V, or Combat Distinguishing Device or Silver Star from a service headquarters signed or stamped "Official Copy"; or
 - Other acceptable official documentation, as determined by the Department.

Any applicable registration, transfer, and Governmental Services Tax, will be charged for issuance or renewal of Disabled Veteran Special license plates. A license plate production fee of \$3.00 per plate, a prison industry fee of \$0.50 per plate, and a technology fee of \$1.00 are charged in addition to all other applicable fees. These plates are exempt from the fees charged for 8-year reissuance of the plates.

If your vehicle is currently registered, you have the option of maintaining your current vehicle registration expiration date, or renewing for a full 12-month period. Credit for any unused portion of your current registration will be applied to your renewal. In applicable counties, if you are renewing for a full 12-month period, and your previous evidence of compliance with emissions standards was obtained more than 90 days ago, the vehicle must be re-inspected prior to registration.
