A. The November 2017 Meeting Minutes were deferred to the next Advisory Board on Automotive Affairs meeting as a quorum was not met.

7. Review of Unfilled Memberships for the Advisory Board on Automotive Affairs

- Richard “Dick” Mills {Wreckers}, advised that the Advisory Board on Automotive Affairs is regulated by NRS 487.002 and that the Advisory Board is missing four members. The public member for counties with a population of 55,000 or less was previously held by Joni Eastley. Richard requested that Gilbert Grieve reach out to Joni for possible member recommendations.
